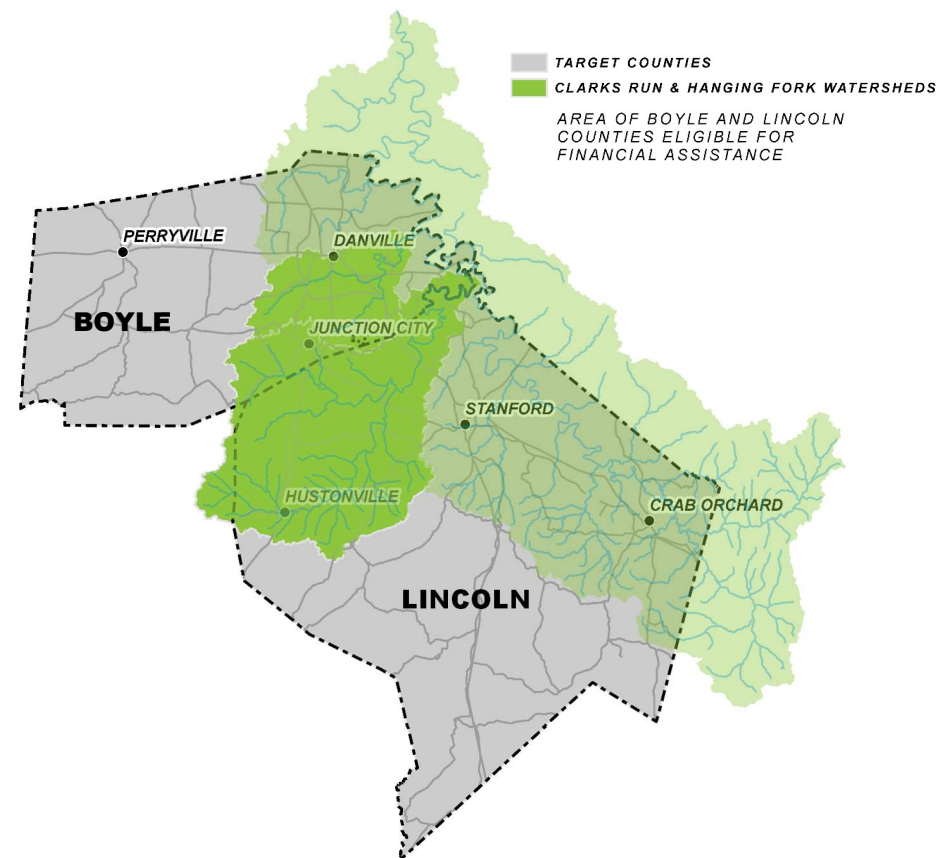

## APPLICATION DEADLINE EXTENDED

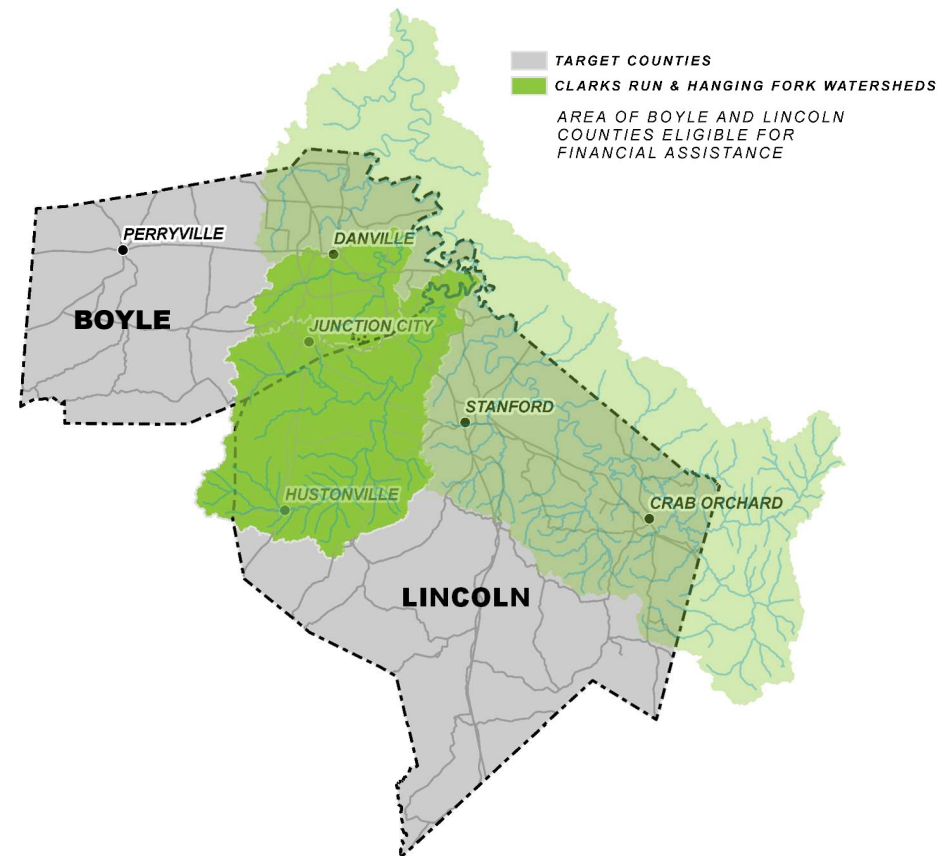
- Up to \$2,000, due **May 31st**
- Eligible area - Clarks Run and Hanging Fork Watersheds
- 2 projects approved in Boyle County to-date
- Public/Community projects
- Private property/backyard stream projects
- Ag projects in conjunction with livestock exclusion, etc.

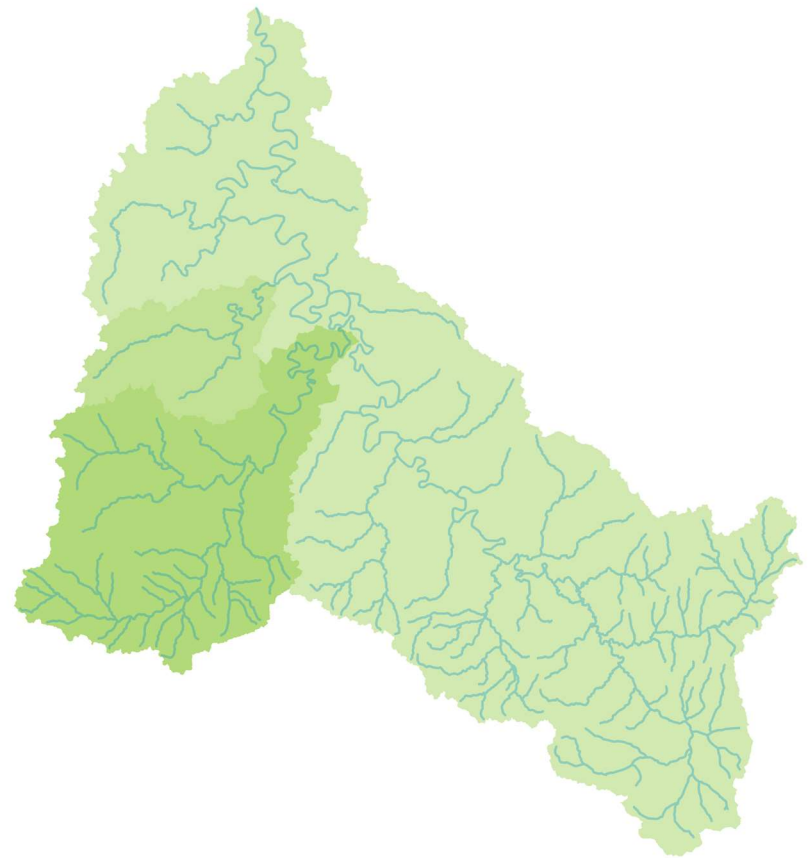
# WATER QUALITY MINI GRANTS

## STAKEHOLDER LED WATERSHED IMPROVEMENT

### Dix River Watershed

- Available to stakeholder group participants
- 5 x \$5,000 projects with 20% match
- Seed money across the watersheds to spark community wide participation and ownership of the watershed improvement program



# PROJECT IDEAS

---

- Watershed Watch engagement and outreach campaign
- Sampler training initiative
- Kayak/boat launches or access points to streams
- Tourism/recreation—water trails or walks
- Water quality sampling/outreach in problem area
- Plantings or stream restoration project
- Litter project or large scale cleanup
- Ag conservation project to connect Farmer-to-Farmer initiative
- Watershed Festival
- Support exiting organization or work
- Green infrastructure project

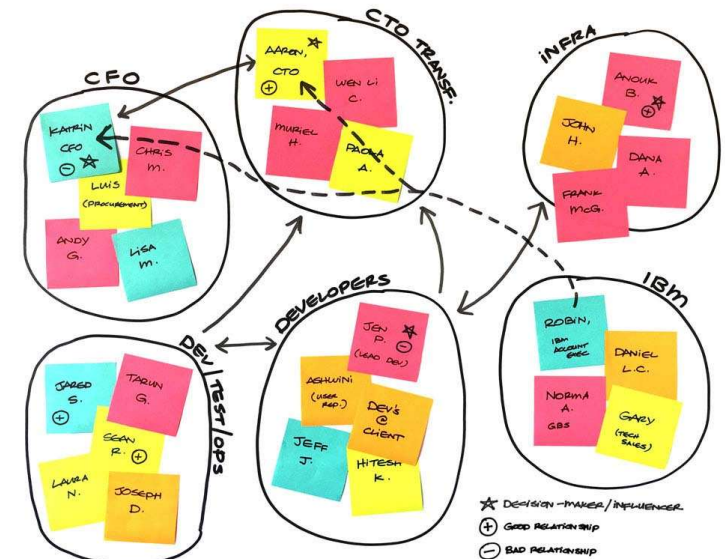

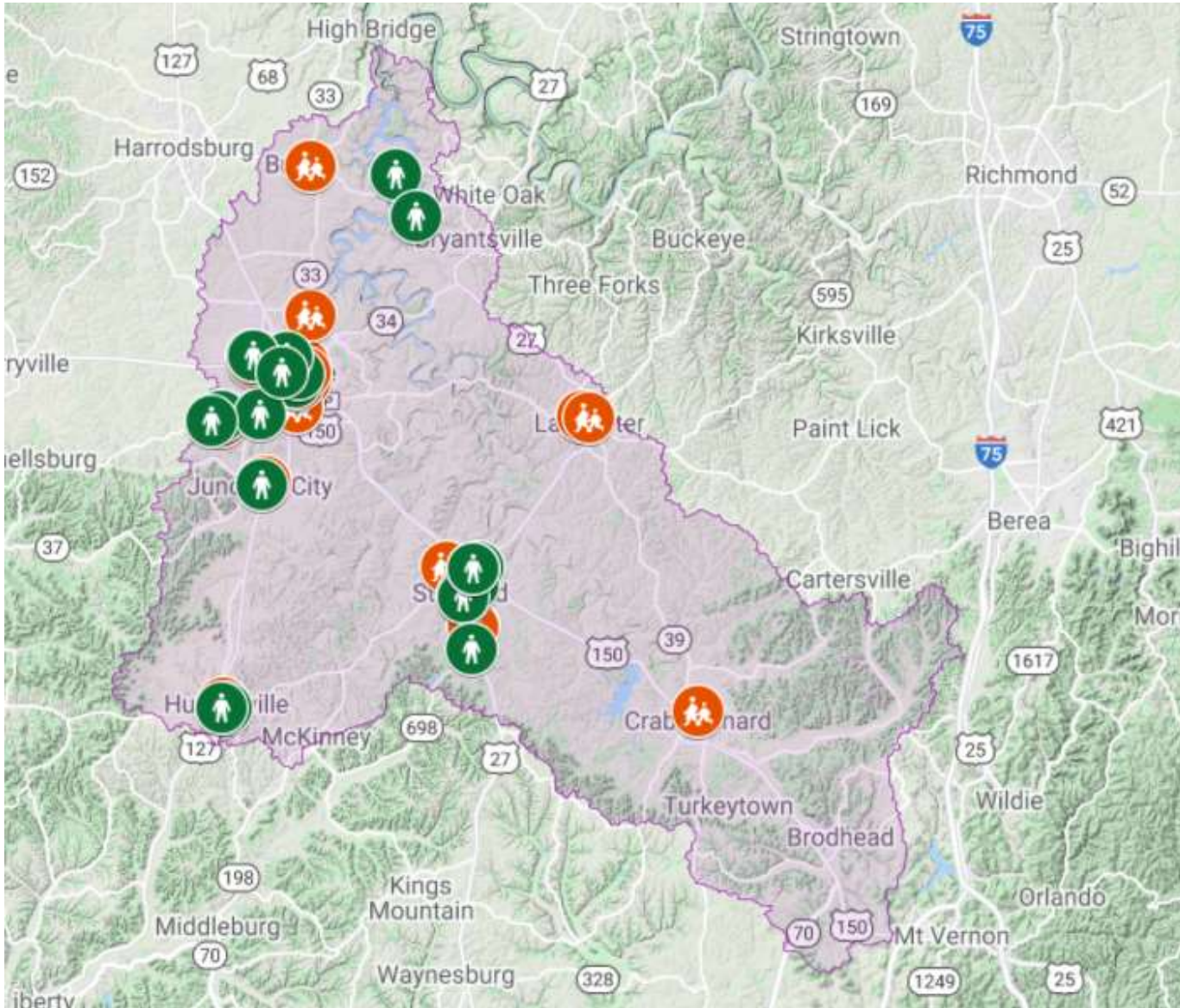

## RANDOM WORD GENERATOR

- Use the link in the email to access the random word generator on your phone: <https://randomwordgenerator.com/>
- We will work with 5 words at a time to develop project ideas through word association
- Ex: wound, fault, grass, **threat**, miserable
  - Invasive species are one of the most common issues that threaten buffers and restoration projects
  - Why don't we have an event where we meet at a park and do large scale invasive species cleanup? We could use grant money to buy tools, hire a company to help, recruit volunteers
- We'll go through several rounds to keep creative juices flowing!
